Susan Jakes and Susan Kelly provided a summary of the reasons why a State Chapter of NACDEP is being formed at this time:

- 1 To provide a professional organization for community development extension professionals in North Carolina, and to participate in NC JCEP.
- 2 To support the professional development activities in CRD and CED in North Carolina.
- 3 To create a NACDEP recruitment organization in North Carolina, for the benefit of both organizations.

Robbie Furr suggested we discuss a little of the vision for this year. For the rest of 2019 the group will meet to further refine the constitution and bylaws and make plans for an Annual Meeting in 2020. There was a discussion of offices, the responsibilities of each and the possibility of electing or appointing a separate position to serve on the NC JCEP Board.

Cameron Lowe explained that once NCACDEP is approved by the NACDEP Board, a letter must be sent to NC JCEP requesting that the organization become a member. Jayne McBurney is NC JCEP President.

\$25 Active

\$25 Affiliate

(Susan Jakes explained that a few specialists have less than 25% Extension appointments and could be affiliate members)

\$100 onetime Life Members

(Decision to grandfather all retirees prior to 2019 in with no fee) 4 X's Active membership fee \$0 Student Membership

A motion to set the dues structure was passed.

The draft Constitution and Bylaws were accepted with a committee consisting of Robbie Furr and Spring Byrd to provide any changes at the first official meeting for affirmation by the membership.

There was a discussion of setting up a bank account for NCACDEP including the options of commercial banks and a Foundation Enhancement Account. Spring mentioned that most banks will not allow association accounts so a Foundation Account to be included in Susan Kelly's district accounts will be explored.
